

16 to 19 Defined Vulnerable Group Bursary Fund Application Form 2021/22

The defined vulnerable group bursary is up to £1,200 per year but could be less depending on the financial need. Eligible students will need to apply for the bursary each year. Students are encouraged to apply in mid-June for the following academic year. Meeting the criteria does not guarantee payment of the bursary if the student's financial needs have already been met by other sources. The deadline for claims for academic year Sep 2021 – Jul 2022 is 31 July 2022.
